**4. Agenda Items:**

- A) Joanne Dorfman, Selection Committee**
- **Approval of WNC Selection Procedures Worksheet**

**Terri stated that the WNC will be holding a Selection on November 8, 2012 at 6 PM  
She introduced Joann Dorfman, the Selection Committee Chair.**

**Joanne stated that ALL NC's have to complete the same worksheet per DONE; and, that  
the WNC Selection Procedures Stipulation Worksheet is required to be approved in the  
Minutes.**

**There was significant discussion about the process and how important it is that everyone  
have confidence and strive to make sure the process is fair and transparent.  
Joanne stated the Selection will be overseen by a neutral third party, Jay Handle and  
reviewed the WNC outreach activities in this regard. She said the minimum age to vote is  
16 and outlined the applications will be available on line on August 20 2012 there will NOT  
be any write-ins and all candidates must be registered by October 8 2012.**

**Steve provided background and stated that Grayce Liu of DONE has acknowledged that  
the system for WNC Selection is consistent with all DONE's advice and that the process is  
transparent.**

**He recapped the prior months of working together with DONE and per their direction the  
work on the By-Law Amendments regarding this process.**

**Steve summarized for clarification:**

- **Only residential stakeholders are qualified to vote on residential seats (and same  
for business seats/stakeholders)**
- **There will be a record of who registers to vote (and who each actually votes for)  
for each seat (so someone would be able to check /question if the voter really qualified).**
- **Self affirmation will be subject to oath, so that someone lying about a prove- able  
fact would be subject to perjury type repercussions**

**If anyone is concerned about any voter wrongfully claiming status, there will be a ability to  
challenge the result (as always). The board expects and asks that the individuals involved  
will all help all to assure that the process is not hijacked by someone trying to mislead on  
the voters qualifications to vote for that seat; and also, if anyone is concerned about any  
voter wrongfully claiming status, there will be a ability to challenge the result (as always).  
Additionally, he noted the self affirmation applies primarily to Seat 17 "at large seat",  
where almost anyone can legitimately claim a stake in our Neighborhood (i.e., they drive  
thru the neighborhood on occasion) and that other self affirmation will be subject to oath,  
so that someone lying about a prove able fact would be subject to perjury type  
repercussions**

**Steve also said there will be a record of exactly who voted for each seat, and the  
independent party appointed for oversight will have sufficient ability to question  
credentials of any voter (since the basis of his or her voting will be verifiable for all other  
seats up for election).**

**It was also noted that the Candidate Town Hall will be held on October 18 2012 at the  
Westside Pavilion (meeting room location and details to follow).**

• **Request to restrict eastbound Pico on to northbound Pelham**  
• **Mobility/LUC Meeting August 13th Meeting Room A 6:30pm**

John spoke in detail about the conditions contributing to the extremely dangerous turn at the corner of Pico and Pellum (eastbound Pico onto northbound Pellum). Lisa provided additional information.

John said the request to restrict traffic at this turn will be considered at the Mobility/LUC Meeting on August 13 2012 at 6:30PM in Meeting Room A.

**D) Alexander Nagy, Food and Water Watch**  
• **Support for Councilmember Koretz Resolution to put moratorium on Fracturing until it is proven safe for public health, Los Angeles water supply and the environment**

Brenda of the organization spoke in detail about their activities in this regard. She explained that Food and Water Watch (FWW) is a public interest consumer organization working to ensure the food and water we consume is safe, accessible, and sustainability produced.

She said they are working on two campaigns. The first campaign is focused on stopping a \$30-50 billion California corporate water grab that will particularly affect Los Angeles residents. Last week Governor Brown announced his plan to fast track building a pair of massive water tunnels near Sacramento. It would potentially be the largest public works project in the history of California. This construction of this tunnel would be a major gift to a few corporate agriculture giants in the Central Valley at the expense of Los Angeles ratepayers and taxpayers. If this passes, Los Angeles residents will be drastically impacted through water rate hikes. FWW has a commissioned an independent economic analysis of the true cost of this pipeline to be released this week - in brief, it will cost Los Angeles anywhere from \$1.6 billion dollars to \$10.9 billion dollars. Councilman Koretz has not taken a position on the tunnel at this time.

The second is the campaign to ban hydraulic fracturing, better known as fracking, in California. She explained that fracking is the process of injecting millions of gallons of water, sand, and toxic chemicals underground at high pressures in order to release oil and gas. Oil companies are fracking here in Los Angeles on the largest urban oil field in the nation, and throughout the state. She noted fracking poses a direct and dire threat to our water and health. She said a growing list of statewide and local organizations, neighborhood councils, homeowners associations are signing on to the letter to Governor Brown and the state legislature asking for a ban on fracking statewide. The most recent local organizations calling for a ban on fracking include: the Baldwin Hills Neighborhood Council, and the Mar Vista Community Council and the Venice Neighborhood Council, just to name a few.

She said they would like the WNC support for the strong resolution on fracking authored by Councilmember Koretz.

Also, that they would like us to consider signing on to the 3 letters.

## **WestFest LA 2012 Event in Century City Saturday Sept. 15th 4:30 - 9:00 PM**

**Officer DeWayne Davis and Jackie  
Mark Chinapen, President, BIG TIME AFFAIRS LLC**

Officer Davis, Jackie and Mark Chinapen presented details for the planned event which is being marketed as LA's Premier Food & Beverage Festival. They said the location is at Constellation Blvd. in Century City, CA. and the event will be held on Saturday, September 15th, 2012, from 4:00 PM to 9:30 PM.

Officer Davis explained that WestFest hosted by and benefiting the West Los Angeles Community Police Station Youth Programs. He spoke to the City's inability to assist in the funding for these valuable programs.

Officer Davis noted that the West Los Angeles Community Police Station is the largest station in Los Angeles covering over 64 square miles - that protects and serves over 500,000 persons each day and 748 street miles, bordering the cities of Beverly Hills, Culver City, and Santa Monica, Los Angeles County and the Pacific Ocean. In comparison to the other 21 community police stations, he said West Los Angeles is responsible for the largest number of square miles and that West LA Community Police Station is a community-focused department that is dedicated to promoting and ensuring the safety, education and welfare of all people throughout the city.

The group spoke about WestFest LA and said it was created to raise awareness and funds for the Youth Programs, which are designed to offer youths an opportunity to develop skills that help them throughout their lives. This includes discouraging involvement in gangs, drugs, encourages academic excellence, volunteerism, and to leverage those achievements to positively impact the community where they live. This is one of the most effective programs for the prevention of gang activity in Los Angeles.

They outlined the following:

**100% of the ticket sales goes directly to West Los Angeles Community Police Station Youth Programs a 501(c) 3 non-profit organization with the following programs:**

**Police Athletic League (PAL):** A youth crime prevention program that relies on educational, athletic and other recreational activities to cement a bond between police officers and the youths ages 6 to 17 years in our community. Team Sports are offered to kids to better themselves and their communities.

**Jeopardy Program:** A gang prevention and intervention program for young people ages 8 to 17 years old that provides youths and their families with tools, guidance and resources necessary for making good choices that prevent them from being drawn into the gang lifestyles and aid them to become a productive adult.

**Juvenile Impact Program (JIP):** The Juvenile Impact Program is to prevent and correct negative or inappropriate behavior in kids ages 9 to 17, by instilling discipline, self- esteem and respect for themselves and others. This accomplished through an intense regimented academic and physical training program much like a military boot camp.

**Deputy Auxiliary Police Services (DAPS):** The DAPS Program introduces kids, ages 8 to 13 to the law enforcement profession and provides the physical and mental preparation necessary to make the transition from DAPS to Cadet Programs or any other department sponsored kids programs.

**Cadet Program:** The purpose of the LAPD Cadet Program is to help instill discipline, leadership, academic excellence and life-skills in all youth participants ages 14-21. The LAPD Cadet Program also seeks to empower students to maximize their personal, scholastic and their personal lives.

They acknowledged the WNC for their support and assistance and said that Sponsorship and Advertising opportunities are available as well as tickets for the event.
